1. INTRODUCTION

The purpose of this circular is to provide you with the notice of the AGM and information regarding resolutions to be proposed at the AGM relating to the approval of: (i) the re-election of Directors; (ii) the Share Issue Mandate; (iii) the Share Repurchase Mandate and (iv) the adoption of New Bye-Laws.

2. RE-ELECTION OF DIRECTORS

As at the Latest Practicable Date, the executive Directors are Mr. Li Weijian, Mr. Zhang He and Mr. Xu Xiang; the non-executive Directors are Mr. Lyu Yanzheng, Mr. Cheng Zhiwei and Ms. Cui Ling; and the independent non-executive Directors are Mr. Zhang Yupeng, Mr. Yuan Mingliang and Mr. Lau Wan Ki.

Pursuant to articles 84 of the Bye-laws, at each annual general meeting, one-third of the Directors shall retire from office by rotation provided that every director is subject to retirement at least once every three years, and a retiring Director shall be eligible for re-election and shall continue to act as a Director throughout the meeting at which he retires. In addition, pursuant to articles 83(2) of the Bye-laws, any Director appointed by the Board to fill a causal vacancy shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election. Accordingly, Mr. Li Weijian, Mr. Xu Xiang, Mr. Cheng Zhiwei, Ms. Cui Ling and Mr. Lau Wan Ki will retire by rotation at the AGM. All retiring Directors are eligible and will offer themselves for re-election at the AGM. The details and brief biography of each of Mr. Li Weijian, Mr. Xu Xiang, Mr. Cheng Zhiwei, Ms. Cui Ling and Mr. Lau Wan Ki is set out in Appendix I to this circular.

The Nomination Committee has recommended to the Board for the re-election of Directors including the independent non-executive director, Mr. Lau Wan Ki in accordance with the following selection criteria:

1. Character and integrity;
2. Qualifications including professional qualifications, skills, knowledge and experience that are relevant to the Company's business and corporate strategy;
3. Willingness to devote sufficient time to discharge duties as a member of the Board and its relevant committees and undertake significant commitments;
4. The number of existing directorships and other commitments that may demand his attention;
5. Requirement for the Board to have independent non-executive Directors in accordance with the Listing Rules and whether such director would be considered independent with reference to the independence guidelines set out in the Listing Rules;
6. Board diversity policy of the Company and any measurable objectives adopted by the Board for achieving diversity on the Board, details of the board diversity policy are set out in the website of Company (www.southmn.com); and
7. Perspectives provided to the management and operation of the Group as well as other contributions to the Group during the tenure of directorship.

The Nomination Committee has assessed the independence of each of the independent non-executive Directors including Mr. Zhang Yupeng, Mr. Yuan Mingliang and Mr. Lau Wan Ki based on reviewing their annual written confirmation of independence to the Company pursuant to Rule 3.13 of the Listing Rules and considered that all of them remain independent.

The Nomination Committee has considered Mr. Lau Wan Ki's extensive experience in finance and accounting, his working profile and other experience and factors as set out in Appendix I to this circular. The Nomination Committee is satisfied that at all times during the period of directorship with the Company since 2021 being the year of his first appointment, Mr. Lau has properly discharged his duties and responsibilities as an independent non-executive Director and has made positive contribution to the development to the Company through independent, constructive and informed comments and participation at the business and other affairs relating to the Group. Mr. Lau has the required character, integrity and experience to continuously fulfil his role as an independent non-executive Director effectively.

The Board believed that re-election of Mr. Lau Wan Ki as independent non-executive Director would be in the best interests of the Company and its Shareholders as a whole.

Accordingly, with the recommendation of the Nomination Committee, the Board has proposed that Mr. Lau Wan Ki stand for re-election as Director at the AGM.

Further information about the Board's composition and diversity as well as the attendance record at the meetings of the Board and/or its committees and the general meetings of the Directors (including the retiring Directors) are disclosed in the corporate governance report of the 2021 annual report of the Company.

3. GENERAL MANDATE TO ISSUE SHARES

At the AGM, an ordinary resolution will be proposed to grant to the Directors a general mandate to allot, issue and deal with new Shares not exceeding 20% of the aggregate nominal amount of the share capital of the Company in issue as at the date of passing of the proposed resolution to approve this Share Issue Mandate.

The Share Issue Mandate will, if granted, remain effective until the earliest of:

- (i) the conclusion of the next annual general meeting of the Company;
- (ii) the expiry of the period within which the next annual general meeting of the Company is required by law or the Bye-laws to be held; or
- (iii) its revocation, variation or renewal by an ordinary resolution of the Shareholders in general meeting of the Company.

In addition, if the Share Issue Mandate and Share Repurchase Mandate are granted, a separate ordinary resolution will be proposed at the AGM to increase the number of Shares which may be allotted and issued under the Share Issue Mandate by the number of Shares repurchased under the Share Repurchase Mandate (up to a maximum of 10% of the aggregate nominal amount of the share capital of the Company in issue as at the date of the grant of the Share Issue Mandate).

As at the Latest Practicable Date, there were 3,428,459,000 Shares in issue. Subject to the passing of the relevant ordinary resolution and on the basis that no further Shares are issued or repurchased prior to the date of AGM, the Company would be authorised under the Share Issue Mandate to issue up to a maximum of 685,691,800 Shares.

4. GENERAL MANDATE TO REPURCHASE SHARES

At the AGM, an ordinary resolution will also be proposed to grant to the Directors a general mandate to repurchase Shares up to 10% of the aggregate nominal amount of the share capital of the Company in issue as at the date of passing of the proposed resolution to approve this Share Repurchase Mandate.

The Share Repurchase Mandate will, if granted, remain in effect until the earliest of:

- (i) the conclusion of the next annual general meeting of the Company;
- (ii) the expiry of the period within which the next annual general meeting of the Company is required by law or the Bye-laws to be held; or
- (iii) its revocation, variation or renewal by an ordinary resolution of the Shareholders in general meeting of the Company.

An explanatory statement in relation to the Share Repurchase Mandate is set out in Appendix II to this circular.

5. ADOPTION OF NEW BYE-LAWS

The Board proposes to amend the Existing Bye-laws in order to (i) update the Existing Bye-laws and bring the Existing Bye-laws in line with the latest regulatory requirements, including the amendments made to Appendix III to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited; (ii) provide for flexibility for the Company to convene and hold hybrid meetings; and (iii) make housekeeping amendments. In view of the number of amendments proposed to be made to the Existing Bye-laws, the Board proposes that the New Bye-laws which consolidate all the proposed amendments to the Existing Bye-laws be adopted as the bye-laws of the Company in substitution for and to the exclusion of the Existing Bye-laws.

The full text of the proposed New Bye-laws (marked-up against the conformed version of the Existing Bye-laws posted on the website of the Stock Exchange) is set out in Appendix III to this circular. The Chinese translation of the proposed New Bye-laws is for reference only. In case of any discrepancy or inconsistency between the English version and its Chinese translation, the English version shall prevail.

The legal advisers to the Company as to Hong Kong laws have confirmed that the proposed New Bye-laws comply with the requirements of the Listing Rules and the legal advisers to the Company as to Bermuda laws have confirmed that the proposed New Bye-laws do not violate the applicable laws of Bermuda. The Company confirms that there is nothing unusual about the proposed New Bye-laws.

6. AGM

At the AGM, resolutions will be proposed to Shareholders in respect of ordinary business to be considered at the AGM. A form of proxy for use at the AGM is enclosed with this circular. Whether or not you are able to attend the AGM, you are requested to complete and return the enclosed form of proxy in accordance with the instructions printed thereon to Computershare Hong Kong Investor Services Limited, 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong as soon as possible and in any event not less than 48 hours before the time appointed for holding the AGM (or any adjournment thereof). Completion and return of the form of proxy will not preclude you from attending and voting in person at the AGM (or any adjournment thereof) should you so wish.

7. VOTING BY POLL

Pursuant to rule 13.39(4) of the Listing Rules, all votes at the AGM will be taken by poll and the Company will announce the results of the poll in the manner prescribed under rule 13.39(5) of the Listing Rules.

8. CLOSURE OF REGISTER OF MEMBERS

The transfer books and register of members will be closed from Friday, 27 May 2022 to Thursday, 2 June 2022, both days inclusive, during which period no transfer of shares will be effected. In order to qualify for attending the AGM, all transfers accompanied by the relevant share certificates must be lodged with the Company's Hong Kong branch share registrar, Computershare Hong Kong Investor Services Limited, at Shops 1712-1716, 17th Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong not later than 4:30 p.m. on Thursday, 26 May 2022.

9. RECOMMENDATION

The Directors believe that the re-election of the Directors, the granting to the Directors of the Share Issue Mandate and the Share Repurchase Mandate and the adoption of the New Bye-Laws are in the best interests of the Company and Shareholders as a whole. The Directors therefore recommend the Shareholders to vote in favour of the resolutions set out in the notice of the AGM contained in this circular.

The following are the particulars (as required by the Listing Rules) of the Directors who will be eligible and offer themselves for re-election at the AGM:

Mr. Li Weijian (李維健), aged 59, joined in 2010 and is currently the Chairman, chief executive officer and executive Director of the Company. He is also a director of several subsidiaries of the Group. He graduated from Shenyang Gold Vocational Training College (瀋陽黃金專科學校) with professional qualifications in mining mechanics in 1982. He obtained a Master of Business Administration degree for senior management from Huazhong University of Science and Technology (華中科技大學) in 2008 and was granted the title of the senior engineer at professor grade in mechanical engineering in 2013 by China Iron and Steel Association and received the special subsidy from the State Council. He was granted “the excellent specialist of Guangxi Zhuang Autonomous Region” by the Guangxi Government. He is a member of the International Manganese Institute, the Chairman of its electrolytic products division as well as the Chairman of the National Manganese Technology Committee. He is also a tutor of the master degree students and a part time professor of various universities. Mr. Li has 36 years of experience in manganese mining and manganese related business, at both the management and operational level and has assumed a wide spectrum of roles in different mining companies.

Mr. Li is a member of the Remuneration Committee and Nomination Committee.

There is a service contract between the Company and Mr. Li. His appointment is for a term of three years commencing from 26 October 2019 but is subject to retirement by rotation and re-election at annual general meetings in accordance with the Bye-laws. Currently Mr. Li is entitled to receive an annual salary of HK\$5,187,000 and a director’s fee of HK\$300,000 per annum. The director’s fee is in line with that paid by the Company to the other executive Director. Mr. Li may at the discretion of the Company receive an annual bonus in addition to his normal remuneration. Apart from the aforesaid, Mr. Li is also eligible to participate in the Company’s share option scheme (if any). Mr. Li’s remuneration is proposed by the Remuneration Committee according to his experience, responsibility, market conditions and the Company’s remuneration policy, and is approved by the Board.

As at the Latest Practicable Date, Mr. Li did not have any other interests in Shares within the meaning of Part XV of the SFO.

Save as disclosed above, Mr. Li does not hold, and has not held, any other positions within the Group and is not connected with any Directors, substantial or controlling Shareholders, or senior management of the Company.

Save as disclosed above, Mr. Li has not in the last three years held any directorship in any other public company the securities of which are listed on any securities market in Hong Kong or overseas.

Save as disclosed above, there is no information relating to Mr. Li that is required to be disclosed pursuant to rules 13.51(2) of the Listing Rules nor are there other matters that need to be brought to the attention of Shareholders in connection with his re-election.

Mr. Xu Xiang (徐翔), aged 27, joined in 2022 as an executive Director of the Company. He is also an assistant general manager of South Manganese Group. He holds a double bachelor's degree in auditing from Nanjing Audit University. From 2017 to 2021, he worked in different audit firm and investment fund management company handling audit, investment and risk management works. Subsequently, he joined South Manganese Group (an indirect wholly-owned subsidiary of the Company) in April 2021 as an assistant general manager. Mr. Xu holds the Fund Practitioner Qualification Certificate and Securities Industry Qualification Certificate. He has extensive experience in the fields of accounting, auditing, investment and risk management.

There is a service contract between the Company and Mr. Xu. His appointment is for a term of two years commencing from 25 March 2022 but is subject to retirement by rotation and re-election at annual general meetings in accordance with the Bye-laws. Currently Mr. Xu is entitled to receive a director's fee of HK\$300,000 per annum. The director's fee is in line with that paid by the Company to the other Executive Director. Mr. Xu may at the discretion of the Company receive an annual bonus in addition to his normal remuneration. Apart from the aforesaid, Mr. Xu is also eligible to participate in the Company's share option scheme (if any). Mr. Xu's remuneration is proposed by the Remuneration Committee according to his experience, responsibility, market conditions and the Company's remuneration policy, and is approved by the Board.

As at the Latest Practicable Date, Mr. Xu did not have any other interests in Shares within the meaning of Part XV of the SFO.

Save as disclosed above, Mr. Xu does not hold, and has not held, any other positions within the Group and is not connected with any Directors, substantial or controlling Shareholders, or senior management of the Company.

Save as disclosed above, Mr. Xu has not in the last three years held any directorship in any other public company the securities of which are listed on any securities market in Hong Kong or overseas.

Save as disclosed above, there is no information relating to Mr. Xu that is required to be disclosed pursuant to rules 13.51(2) of the Listing Rules nor are there other matters that need to be brought to the attention of Shareholders in connection with his re-election.

Mr. Cheng Zhiwei (程智偉), aged 58, joined in 2019 as a non-executive Director of the Company. Mr. Cheng was a deputy director and then a director of the supervisory board of State-owned Assets Supervision and Administration Commission of the People's Government of Guangxi Zhuang Autonomous Region (“**SASAC of Guangxi**”) (the indirect controlling shareholder of Guangxi Dameng) and a supervisor of various subsidiaries of SASAC of Guangxi (including but not limited to Guangxi Liuzhou Iron and Steel Group Co., Ltd. (formerly known as Guangxi Liuzhou Iron and Steel (Group) Company), Guangxi Liugong Group Co., Ltd., Guangxi Automobile Group Co., Ltd. (formerly known as Liuzhou Wuling Motors Co., Ltd.)) from 2008 to 2013. He was also a director and general manager of Guangxi Guowei Asset Management Co., Ltd. (a subsidiary of SASAC of Guangxi) from 2013 to 2014. He has been a director and general manager of Guangxi Dameng since September 2014 and was re-designated as its chairman in August 2017 and worked up to and resigned in July 2020. Mr. Cheng graduated from Central South University with a bachelor degree in laws and obtained a postgraduate certificate in philosophy of science and technology (economic development and social management focus) from Guangxi University. He has the senior economist and lawyer professional qualifications in the People's Republic of China.

There is a service contract between the Company and Mr. Cheng. His appointment is for a term of three years commencing from 1 July 2019 but is subject to retirement by rotation and re-election at annual general meetings in accordance with the Bye-laws. He is entitled to receive a director's fee of HK\$300,000 per annum. The fee is in line with that paid by the Company to the other non executive Director. Apart from the aforesaid, Mr. Cheng is also eligible to participate in the Company's share option scheme (if any). Mr. Cheng's remuneration was proposed by the Remuneration Committee according to his experience, responsibility, market conditions and the Company's remuneration policy, and was approved by the Board.

As at the Latest Practicable Date, Mr. Cheng did not have any other interests in Shares within the meaning of Part XV of the SFO.

Save as disclosed above, Mr. Cheng does not hold, and has not held, any other positions within the Group and is not connected with any Directors, substantial or controlling Shareholders, or senior management of the Company.

Save as disclosed above, Mr. Cheng has not in the last three years held any directorship in any other public company the securities of which are listed on any securities market in Hong Kong or overseas.

Save as disclosed above, there is no information relating to Mr. Cheng that is required to be disclosed pursuant to rules 13.51(2) of the Listing Rules nor are there other matters that need to be brought to the attention of Shareholders in connection with his re-election.

Ms. Cui Ling (崔凌), aged 46, joined in 2019 as a non-executive Director of the Company. She is a dispatch director and chief financial officer of Guangxi Dameng. Ms. Cui was the head of financial department of Linan Railway Co., Ltd (an associate company of Guangxi Railway Investment Group Co., Ltd. (“**Guangxi Railway**”) (the direct controlling shareholder of Guangxi Dameng)) from 2011 to 2012. She has held many positions in Guangxi Railway and certain of its subsidiaries since May 2012 including the deputy head of finance and planning department of Guangxi Railway from 2014 to 2018. She was re-designated as the deputy general manager and chief financial officer of Guangxi Dameng in July 2018. Ms. Cui graduated from Beijing Jiaotong University with a bachelor degree in accounting and has the certified senior accountant qualification in the People’s Republic of China.

Ms. Cui is a member of the Audit Committee.

There is a service contract between the Company and Ms. Cui. Her appointment is for a term of three years commencing from 1 July 2019 but is subject to retirement by rotation and re-election at annual general meetings in accordance with the Bye-laws. She is entitled to receive a director’s fee of HK\$300,000 per annum. The fee is in line with that paid by the Company to the other non executive Director. Apart from the aforesaid, Ms. Cui is also eligible to participate in the Company’s share option scheme (if any). Save as disclosed above, there is no information relating to Ms. Cui that is required to be disclosed pursuant to rules 13.51(2) of the Listing Rules nor are there other matters that need to be brought to the attention of Shareholders in connection with her re-election.

Mr. Lau Wan Ki (劉運祺), aged 37, joined in 2021 as an independent non-executive Director. He has over 14 years of experience in the field of corporate finance and accounting. Mr. Lau currently serves as an executive director of Yue Xiu Capital Limited. From 2007 to 2011, he worked at the audit department of KPMG in Hong Kong with his last position as assistant manager. He then served various positions at China Tonghai Capital Limited (a subsidiary of China Tonghai International Financial Limited (Stock Code: 0952.HK)) from 2011 to 2015 with his last position as senior manager. After that, Mr. Lau served at Lego Corporate Finance Limited (a subsidiary of LFG Investment Holdings Limited (Stock Code: 3938.HK)) from 2016 to 2020 with his last position as executive director.

Mr. Lau obtained his Bachelor of Business Administration (Hons) in Finance from City University of Hong Kong in 2007. He is licensed under the SFO as a representative to carry out Type 1 (dealing in securities) regulated activities and a responsible officer to carry out Type 6 (advising on corporate finance) regulated activities. He also has the qualifications of certified public accountant, chartered financial analyst and financial risk manager.

There is a service contract between the Company and Mr. Lau. His appointment is for a term of two years commencing from 31 July 2021 but is subject to retirement by rotation and re-election at annual general meetings in accordance with the Bye-laws. He is entitled to receive a director's fee of HK\$300,000 per annum. The fee is in line with that paid by the Company to other independent non-executive Directors. Apart from the aforesaid, Mr. Lau is also eligible to participate in the Company's share option scheme (if any). Mr. Lau's remuneration was proposed by the Remuneration Committee according to his experience, responsibility, market conditions and the Company's remuneration policy, and was approved by the Board.

Mr. Lau met the independence guidelines as set out in Rule 3.13 of the Listing Rules and the Company has received his annual written independence confirmation and considered him to be independent. Therefore, the Board considers Mr. Lau is still independent and should be re-elected.

As at the Latest Practicable Date, Mr. Lau did not have any other interests in Shares within the meaning of Part XV of the SFO.

Save as disclosed above, Mr. Lau does not hold, and has not held, any other positions within the Group and is not connected with any Directors, substantial or controlling Shareholders, or senior management of the Company.

Save as disclosed above, Mr. Lau has not in the last three years held any directorship in any other public company the securities of which are listed on any securities market in Hong Kong or overseas.

Save as disclosed above, there is no information relating to Mr. Lau that is required to be disclosed pursuant to rules 13.51(2) of the Listing Rules nor are there other matters that need to be brought to the attention of Shareholders in connection with his re-election.

This Appendix II serves as an explanatory statement, as required by the Share Repurchase Rules, to provide requisite information to you for your consideration of the Repurchase Resolution, the approval of which will grant a general mandate to the Directors to exercise the power of the Company during the period as set out in the Repurchase Resolution to repurchase Shares up to a maximum of 10% of the issued share capital of the Company as at the date of the passing of the Repurchase Resolution.

1. SHARE REPURCHASE RULES

The Share Repurchase Rules permit companies whose primary listing is on the Stock Exchange to repurchase their fully paid up shares on the Stock Exchange subject to certain restrictions, the most important of which are summarised below:

(a) Shareholders' Approval

The Share Repurchase Rules provide that all on-market share repurchase by a company with its primary listing on the Stock Exchange must be approved in advance by an ordinary resolution, either by way of a specific approval in relation to specific transactions or by a general mandate to the directors of the company to make such repurchase.

(b) Source of Funds

Share repurchase must be made out of funds which are legally available for the purpose and in accordance with the company's constitutive documents and the laws of the jurisdiction in which the company is incorporated or otherwise established.

(c) Maximum Number of Shares to be Repurchased and Subsequent Issue

The shares to be repurchased by a company must be fully-paid up. A maximum of 10% of the existing issued share capital of a company as at the date of passing of the relevant resolution may be repurchased on the Stock Exchange and a company may not, without the prior approval of the Stock Exchange, issue new shares or announce a proposed new issue of shares for a period of 30 days immediately following a share repurchase whether on the Stock Exchange or otherwise (other than an issue of securities pursuant to the exercise of warrants, share options or similar instruments requiring the company to issue securities, which were outstanding prior to the repurchase).

2. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 3,428,459,000 Shares. Subject to the passing of the Repurchase Resolution and on the basis that no further Shares are issued and no Shares are repurchased prior to the AGM, the Company will be allowed, if the Repurchase Resolution is approved, to repurchase a maximum of 342,845,900 Shares representing not more than 10% of the issued share capital of the Company as at the date of passing of the Repurchase Resolution.

3. REASONS FOR REPURCHASE

The Directors believe that the Share Repurchase Mandate is in the best interests of the Company and Shareholders as a whole. Share repurchase may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net assets and/or earnings per Share and will only be made when the Directors believe that such a repurchase will benefit the Company and Shareholders as a whole.

4. FUNDING OF REPURCHASE

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with the Bye-laws and the applicable law of Bermuda.

5. IMPACT OF REPURCHASE

There might be an adverse impact on the working capital or gearing position of the Company, as compared with the position disclosed in the audited consolidated financial statements of the Company as at 31 December 2021, in the event that the share repurchase under the Share Repurchase Mandate were to be carried out in full at any time during the proposed repurchase period. However, the Directors will not propose to exercise the Share Repurchase Mandate to an extent where it would, in the circumstances, have a material adverse effect on the working capital requirements or gearing levels of the Company or which in the opinion of the Directors are from time to time inappropriate for the Company.

7. UNDERTAKING

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the powers of the Company to make the share repurchase pursuant to the Share Repurchase Mandate in accordance with the Listing Rules and the applicable laws of Bermuda.

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, their close associates (as defined in the Listing Rules) have any present intention to sell any Shares to the Company or its subsidiaries under the Share Repurchase Mandate if such mandate is approved by Shareholders.

No core connected persons (as defined in the Listing Rules) have notified the Company that they have a present intention to sell Shares to the Company or its subsidiaries, or have undertaken not to do so, in the event that the Share Repurchase Mandate is approved by Shareholders.

8. TAKEOVERS CODE

If on the exercise of the power to repurchase Shares pursuant to the Share Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purposes of Rule 32 of the Takeovers Code. As a result, a Shareholder or group of Shareholders acting in concert (within the meaning under the Takeovers Code) could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rules 26 and 32 of the Takeovers Code.

To the best knowledge of the Company, as at the Latest Practicable Date, Youfu Investment Co., Ltd., was interested in 994,260,000 Shares, representing approximately 29.00% of the issued Shares. Youfu Investment Co., Ltd. is wholly owned by Mr. Sun Mingwen. In the event that the Directors exercise in full to repurchase Shares under the Share Repurchase Mandate, the shareholding of Youfu Investment Co., Ltd. would be increased to approximately 32.22% of the issued Shares. As a result, such an increase of shareholding would give rise to an obligation for Youfu Investment Co., Ltd. and Mr. Sun Mingwen to make a mandatory offer under Rule 26 of the Takeovers Code.

Save as aforesaid, the Directors are not aware of any consequences which may arise under the Takeovers Code as a consequence of any purchases made under the Share Repurchase Mandate. The Directors have no intention to exercise the Share Repurchase Mandate which may result in a possible mandatory offer being made under the Takeovers Code. The Directors will use their best endeavours to ensure that the Share Repurchase Mandate will not be exercised to the extent that the number of Shares held by the public would be reduced to less than 25% of the issued share capital of the Company.

9. SHARE REPURCHASE BY THE COMPANY

Neither the Company nor any of its subsidiaries has repurchased any Shares (whether on the Stock Exchange or otherwise) in the six months preceding the Latest Practicable Date.
